Circus Market in the Center of Kerava

Saturday, 10 September and Sunday, 11 September 2022

The Circus Market is coming again. At the same time, Suomen Tivoli will also arrive in the city. The Circus Market is being developed and circus art and cultural content as well as events are becoming more and more central to the event. The autumn market is still part of this traditional Kerava event.

The market area of the Circus Market is in the center of Kerava on Paasikivenkatu and Kauppakaari.

We have changed the registration to be based on an application form. In the future, slots will be allocated based on search criteria and the aim is to use them to develop the event.

We will process applications as they arrive. You will receive a notification about the location no later than 5 August 2022. Slots will be placed in the event area during August.

Application to be a vendor will be done this year on the following schedule:

10 June 2022-> Apply to be a vendor in the Circus Market with this form: Slots will be filled according to the search criteria. You will receive a confirmation of the slot no later than the beginning of August.

5 August 2021 Registrants will be notified of their vendor slot by email. After that, those who have registered have seven days to cancel their registration. If the slot is not canceled, it will be billed on 12 August 2022.

19 August 2021 Invoicing of the slots.

Registration is binding, and the slot can no longer be canceled after invoicing on 12 August 2021.

CRITERIA TO IMPROVE SELECTION

Sales activity:

- The product is of high quality
- The brand or concept is unique
- Ecology
- Content related to circus, art, or other functional cultural activities (circus / Tivoli / art theme).
- Local food products suitable for the autumn market: berries, mushrooms, flowers, seasonal products, local food
- Crafts
- Experiential gifts

Restaurant operators:

- The food product range considers special diets as well as vegetarian and vegan food.
- The product is of high quality
- The product is suitable for the theme of the event

Slots will not be given to:

- Political or religious content / actors.
- No presentation of the activity, unless it is somehow related to the theme of the event: Circus, art, or other functional presentation of cultural activities.
